HELLO FROM THE TD HALIFAX JAZZ FESTIVAL!

The TD Halifax Jazz Festival welcomes you to our festival! We strongly believe in music education and access to music for young folks, which is why we have a special liquor license on our Waterfront Stage that allows youth under 19 years of age to attend concerts while accompanied by their Parent/Legal Guardian/Primary Caregiver.

If you are under 19 years of age or a Parent/Legal Guardian/Primary Caregiver of a minor, and you want to attend a Waterfront Stage concert together, please fill out the form(s) below.

Application Section 1 is for the direct concert attendees: Parent/Legal Guardian/Primary Caregiver and underage person who are attending the concert.

Application Section 2 is the Appointment of Temporary Legal Guardianship form.

If you are a parent giving consent to a legal guardian of your child, please fill out both sections 1 and 2 of the Underage Application Form.

The TD Halifax Jazz Festival defines a "parent" as *"a biological parent of the minor, OR, one whom has been appointed by the court, OR, one whom is the child's primary caregiver"*. The TD Halifax Jazz Festival defines a "temporary legal guardian" as *"someone who has written consent from the parent of the minor, and who is at minimum 30 years of age"*.

IMPORTANT INFO

The TD Halifax Jazz Festival reserves the right to remove underage attendees and their Parent/Legal Guardian/Primary Caregiver or Temporary Legal Guardians from access to the Waterfront Stage and/or will not refund concert tickets in the event they fail to comply with the rules listed below:

- **Parents/legal guardians/primary caregivers and Temporary Legal Guardians must not allow the underage attendee in their care to imbibe in any illegal substances.**
- **Should an underage attendee in your care imbibe in any illegal substances, you shall notify our Security and Safety team immediately.**
- **Parents/legal guardians/primary caregivers and Temporary Legal Guardians must be sober and in control at all times while on site at the TD Halifax Jazz Festival.**
- **Parents/legal guardians/primary caregivers and Temporary Legal Guardians must stay in close proximity to the underage attendee in their care, and know their precise location at all times.**
- **Parents/legal guardians/primary caregivers and Temporary Legal Guardians are entirely responsible for the behaviour of the underage attendee in their care.**
